**Categories** Oil/Acrylic/Watercolor Painting, Sculpture, Photography, Drawing/Pastels, Mixed Media.

**Eligibility** Artists must reside in the greater MetroWest area of Essex, Morris, Sussex and northern Union counties.

**Submissions JPEG IMAGES ONLY on CD.** Must be under 1600 pixels in any direction at 300 dpi or no larger than 1 MB. Must be readable by Macs and PCs. Label each image as follows: Last Name-Title-Entry# (Example: Suss-Winter-3). No identifying text on image. Write your name on CD. **Note: Works may not exceed 48" in any direction.** Up to 3 entries. (Sculptors may submit 2 views of each.) Original work only. No giclees. Do not submit work shown at a previous Gaelen Juried Art Show. Price your work to sell.

**Awards** Cash awards for Best In Show, Best Of Category and Honorable Mention. JCC gallery exhibit for Best in Show and Best of Category.

**Application Fee** \$40 for up to 3 entries, non-refundable. Check payable to JCC MetroWest must accompany this application. All entries must include a stamped, self-addressed 7"x10" envelope for return of your CD and invitation postcards if accepted.

**Insurance and Delivery** No insurance or storage is provided. All work must be original. **2-D submissions, including photography, must be suitably framed and wired for hanging.** No sawtooth hangers. Art must be clearly labeled with the artist's last name, title and medium. Pedestals are provided for sculpture. No electricity is available.

**Jurors** Marjorie Frankel Nathanson, Executive Director, Hunterdon Art Museum; Andy Foster, Owner, Gallery 51, Montclair, NJ; Mimi Weinberg, sculptor and installation artist, professor, Seton Hall and Montclair State Universities.

**Conditions of Agreement** Selected works must remain for the duration of the exhibition. No substitutions. JCC MetroWest reserves the right to reproduce entries for publicity and catalog. 35% commission taken on all sales. A contractual agreement between JCC MetroWest and the artists will be formalized with acceptance. Work remaining after the pickup dates will be disposed of at the discretion of JCC MetroWest.

**CALENDAR 2012:** Submit only if you can follow all entry, delivery and pickup dates. No exceptions.

**Friday, February 3** — Entry deadline.

**Friday, March 16** — Notification of acceptance.

**Monday, May 14** — Delivery of all accepted work: 11:00 AM - 1:00 PM and 6:00 PM - 7:30 PM.

**Sunday, May 20** — Opening reception by invitation only, 2:00 PM - 4:00 PM; awards presented at 2:30 PM.

**Monday, June 25** — Artists pick up of exhibited work: 11:00 AM - 1:00 PM and 6:00 PM - 7:30 PM.
