Non-refundable deposit

- 10 month part-day programs:** To enroll your child in the JCC MetroWest Early Childhood Program the applicant is required to submit a non-refundable deposit of \$500. The deposit will be evenly credited toward the monthly tuition fee. **After March 15th, 2018, annual tuition will increase by \$250, the non-refundable deposit will be \$750 and \$500 will be credited toward the annual tuition fee.**
- 10 and 12 Month full day programs (7:30-6:00)** To enroll your child's registration in the JCC MetroWest Early Childhood Program, the applicant is required to submit a non-refundable deposit of \$500. The deposit will be evenly credited toward the monthly tuition fee. **After March 15th, 2018, annual tuition will increase by \$500, the non-refundable deposit will be \$1,000, and \$500 will be evenly credited toward the monthly tuition fee.**

Program Eligibility
In addition 12 month Full Day (7:30-6:00) children are eligible for the following summer benefits:

- Automatically enrolled in JCC ECC summer camp program.** Camp Deeny Riback (3.5y/or and potty trained) or JCC MetroWest EC Camp.
 - Pre-camp** (June 16, 17, 18, 19,20,21) at JCC ECC for children attending EC camp . Pre-registration required.
 - Post-Camp** (Aug. 19,20,21,22,23) (CDR campers must attend CDR post camp/week 9). Pre-registration is required, limited spaces available.

10 or 12 month Full Day (7:30-6) children are eligible for the following:

- Vacation Day** programs & **Jewish Holiday** programs (please refer to school calendar)
- Priority registration in **Mini Camp** programs for winter break (Dec. 24, Dec. 26,27,28,29,31) & Spring Break (April 22, 23,24,25,26) are available at a daily rate of **\$65/per day**.

Sibling Discount - Please enjoy 5% off of the annual tuition of your 2nd enrolled child and 10% off of the annual fee of your third enrolled child. Discount will be taken from the less costly tuition.
